How to receive email alerts

- **Get email alerts**

- Users need to sign up for an account to receive notifications via email. You will be able to [modify and make changes to your account settings](#) and all your alerts later. Users may have multiple alerts set up.

- **To receive committee agendas:**

1. Go to the main calendar page [here](#) and sign in
2. Under the Calendar tab, select “All Years”
3. Select the committee you would like to subscribe to
4. On the top right, click the Alerts button

- **To receive correspondence and file notification:**

1. Go to the main calendar page [here](#) and sign in
2. Under the Legislation tab, select “All Years” and type of document. (Select “All Types” to receive all)
3. Enter a keyword in the search field. Ex: “county manager”, “John Smith” or “Wailuku.” Click on Search or hit enter.
4. The Alerts icon on the upper right of the platform will become active. Click on the Alerts icon.
5. Select how often you would like to receive alerts
6. Add alert

- Repeat steps to add more keywords and alerts.

Oral and Written Testimony

Oral or written testimony on any agenda item will be accepted. Each testifier shall be allowed to speak for up to three minutes on each item. If approved by the presiding officer and announced prior to any oral testimony being taken, the testifier may be allowed one minute to conclude the testimony on the item. The time limits for testimony at a Council meeting may be modified, if the modification is initiated by the presiding officer and approved by a majority of the Council; provided that a modification would apply equally to all testifiers and all items. No further oral testimony by the testifier on the item shall be permitted. An individual's request to testify may be deemed withdrawn if the individual does not answer when called to testify.

Individuals may provide oral testimony by phone or video conference. To join the meeting by phone, call 1 408-317-9253 and input meeting code 295235670. To join by video conference, use the following link: <https://maui.bluejeans.com/295235670>.

Testifiers will be asked to disconnect from the video conference meeting once their testimony has concluded. Once the testimony period has closed, only the Councilmembers, staff, and designated resource persons will be connected to the video conference meeting. All other individuals will be disconnected. Individuals wanting to view the remainder of the meeting may do so on Akaku Channel 53 or at <https://mauicounty.legistar.com>. Individuals may be disconnected from the meeting for breaking decorum.

Written testimony may be submitted by e-mail to county.clerk@mauicounty.us, by fax to (808) 270-7171, or to the Office of the County Clerk, 200 South High Street, Suite 708, Wailuku, Hawaii, 96793. Written testimony must be received at least 24 hours prior to the meeting; provided, that if a meeting will be held on a Monday, written testimony shall be received by 12:00 noon on the business day preceding the meeting.
